In this regard, I am to inform you that permission is hereby granted to open unaided English Medium Primary School (CBSE Syllabus), Std. Ist at Gurukul Academy Primary School, Durgabhat, Ponda- Goa, (without Government grants) from the academic year 2011-2012, as per Rule 31(3) of the Goa School Education Rules 1986 subject to the fulfillment of all the conditions laid down in Chapter III and also compliance of all other provisions stipulated in the Goa School Education Act, 1984 and the Goa School Education Rule, 1986 and the instructions issued by Director of Education/Government from time to time

1. Before commencing with the said standard, the Management should report the arrangement for providing suitable accommodation, necessary furniture and other equipments, the arrangement made/proposed to be made for providing the necessary staff to Dy. Education Officer concerned and only when he is satisfied with the said arrangement, the class should start functioning otherwise the permission granted shall automatically stands cancelled.
2. Facilities for drinking water, sanitation, language teaching, History and Geography teaching, Science teaching, Sports and Games etc. shall be made available.
3. No further permission will be granted to change the medium of instruction.
4. Trained teachers with adequate qualification should be appointed.
5. The teaching and non-teaching staff should be paid their salaries by cross cheques, on par with their counterparts in Government/Government aided School and they shall be made admissible for all service and retirement benefits.
6. The School shall comply as per section 18 of the Right of Children to free & compulsory Education Act, 2009.

7. The School Managing Committee should be constituted as per Rule 46 of the Goa School Education Rule, 1986.
8. The School shall admit maximum of 25 students. They should not enroll the students of neighbouring schools and they should admit only the students of its own preprimary school.
9. The school shall file statement of fees to be charged every year in the month of May/June for the approval of Director of Education without fail.

This is only permission for starting class and not recognition for the said class. The school has to satisfy all the conditions of the Right of Children to Free and Compulsory Education Act 2009 and Goa School Education Rules, 1986, for grant of recognition. The same is required to be obtained by submitting application in Form -I under said Rule 36 immediately after opening of class.

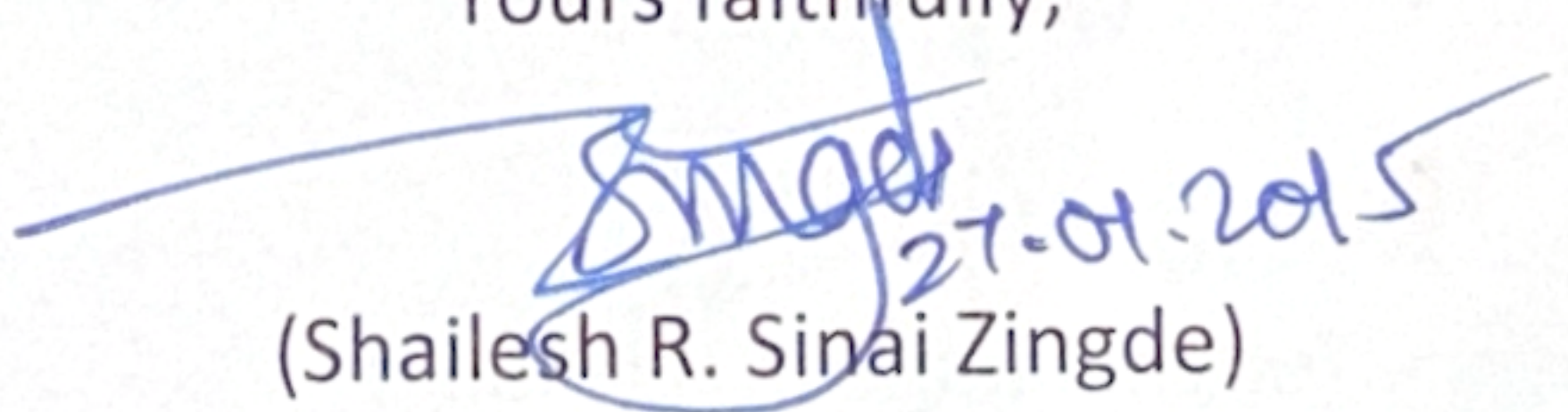
